KO E TALATEU MO E VAKAI ‘A E ‘ATITA SENIALE

‘Oku’ou faka’apa’apa ke’u fakahoko atu henri ‘a e Fakamatala Fakata’u ‘a e ‘Ofisi ‘o e ‘Atita Seniale (TOAG), ki he ta’u fakapa’anga 2017–18.

Na’e faka’ilonga’i ‘a e ta’u’ni ‘aki ‘a hono fakahoko ‘o e ngaahi ngāue faka’atita ki he ngaahi potungāue mo e ngaahi kautaha fakapule’anga pea ‘oatu ai ‘a e ngaahi lipooti mo e ngaahi fale’i tau’ataina mo taau ki he Fale Alea, Pule’anga, mo e ngaahi komiuniti. Hangē ko ia kuo fokotu’u ‘i he ‘emau visone, ko e taumu’ā’ ke ma’u ha pule’anga ‘oku *angā haohaoa, taliui mo ‘ata ki tu’ā* ‘ene ngaahi ngāue fakapa’anga.

Ko e Vakai Fakalukufua

Na’a’mau fakahoko ‘a e ngaahi ‘atita ‘o e ngāue fakapa’anga mo e faipau ki he lao’ ‘o hangē ko ia na’e palani ki he ta’u 2017–18. Na’e lava ai ke’mau ‘atita ‘a e ngaahi fo’i ‘iunimi ‘atita ‘e 18, (‘i he ngaahi Potungāue mo e ngaahi kautaha ‘a e pule’anga), ngaahi fakamatala pa’anga ‘e 17, vakai’i ‘a e ngaahi fo’i ‘atita ‘e 11, fakatotolo makehe ‘e 2 pea mo e ngaahi tohi fakamo’oni ‘e 132. Ko e ngaahi isiū ‘e 62 na’a’mau ‘oatu ‘i he ‘emau lipooti pea mo ha fokotu’u ‘e 150 ke fai ha tokanga mo fai ha ngāue ki ai ‘a e kau pule ngāue.

Na’e kakato foki mo e ‘atita ki he ngaahi Fakamatala Pa’anga ‘a e Pule’anga’ ki he ta’u ‘oku ngata ki he ‘aho 30 ‘o Sune, 2018 pea ‘oatu ‘a e tala fakakaukau ‘a e ‘Atita’ ‘i he ‘aho 27 ‘o Fepueli, 2019.

Hangē pe ko ia ko e aofangatuku faka’atita ‘o e ngaahi ta’u ki mu’ā, na’e ‘oatu ‘a e tala fakakaukau ‘ikai haohaoa ‘a e ‘Atita. Ko e makatu’unga’ ko e ‘ikai muimui pau ‘a hono teuteu mo fai ‘o e ngaahi fakamatala pa’anga ki he Ngaahi Sipinga Tauhitohi Fakavaha’apule’anga ki he Pa’anga Fakapule’anga, IPSAS, Makatu’unga ‘i he Fehū’aki Pa’anga, kae ngāue’aki ‘a e founiga tānaki atu ki ai ‘o mavahé mei he IPSAS. ‘Oku fai ‘a e feinga ko ‘eni ke fokotu’u ‘a e mahu’inga totonu ‘o e ngaahi koloa mo e ngaahi mo’ua ‘o e Pule’anga ‘i he fakamatala pa’anga ‘o e ta’u fakapa’anga ko ia. ‘Oku ngāue fakataha ‘a e ‘Ofisi ‘o e ‘Atita Seniale mo e ‘Ofisi ‘o e Minisitā Pa’anga mo Palani Fakafonua ke fakakakato ‘a e ngāue ko eni. Kae lolotonga ‘ene te’eki ai kakato’, ‘e kei tu’u tatau ai pē ‘a e aofanagtuku ‘a e ‘Atita.

Ko e ngaahi ola na’e ma’u mei he ngaahi ‘atita ‘o e ngāue fakapa’anga mo e faipau ki he lao’ lolotonga ‘a e ta’u’ ‘oku fakahoko atu ia ‘i he lipooti mavahé ki he Sea ‘o e Fale Alea, “‘Atita ‘o e Ngaahi Ngāue Fakapa’anga mo e Faipau ki he Lao 2017–18,” tatau pē mo e 2016–17.

Kaekehe, hangē ko e ngaahi ta’u ki mu’ā, na’e kei nounou ‘aki pe ‘a ‘emau ‘atita’i ‘o e maa’usia ‘o e ola ‘i he ‘ikai ke maa’usia ‘o e palani ki he ta’u. Ko e pole lahi eni ki he TOAG he na’e te’eki ai ke ma’u ha taukei pe poto’i fe’unga ki he fakahoko ‘o e ‘atita ki he maa’usia ‘o e ola. ‘Oku’mau lolotonga feinga ki ha fa’ahinga faingamalie te’mau ala ma’u ke teuteu’i ai ha maheni pe taukei ngāue ‘i he ‘atita ‘o e maa’usia ‘o e ola.

Polokalama Ako Fakalakalaka Fakapolofesinale ‘o e Kaungāue

Na’e hokohoko mai pē ‘a e polokalama ako fakalakalaka fakapolofesinale ‘o e kaungāue lolotonga ‘a e ta’u. Ko e ‘Atita, Setila Eke na’e mavahé atu ia ‘o ako ki he Graduate Diploma ‘i he Tauhitohi Fakapolofesinale ‘i ‘Aokalani, Nu’usila. ‘Oku kei hokohoko atu pe ‘a e ako ‘a e ‘Atita Pule, Lotomo’ua Tu’ungafasi ki hono MA he Tauhitohi Fakapolofesinale ‘i he ‘Univēsiti ‘o Niusauele, ‘Aositelelia pea ko e Tauhitohi, ‘Akuila Lomu ‘oku lolotonga ako ki hono BA ‘i he ‘Univēsiti ‘o Vikatōlia ‘i Uelingatoni, Nu’usila. Kuo kakato ‘a e ako ‘a e ‘Atita Pule, Fatafehi Taumoha’apai ki hono MA he Tauhitohi Fakapolofesinale mei ‘Aokalani, Nu’usila pea mo e ‘Atita, Filatoa Vailea ki hono MA ‘i he ‘Ekonōmika mei Shanghai, Siaina pea kuo’na foki mai o hoko atu ‘o e fakahoko fatongia.

‘Oku kei hokohoko atu pe ‘a e ngaahi polokalama ako ‘a e PASAI ‘oku ‘omai ki he TOAG ‘i he ngaahi lēvolo kehekehe, ko e tanumaki ai pe ki he poto’i ngāue mo e taukei ‘a e kaungāue. ‘Oku’ou fie fakamālō’ia henri ‘a e ngaahi tokoni fakapa’anga kotoa pē mei he Pule’anga ‘Aositelēlia, DFAT, ‘a ia ‘oku’ne fakapa’anga ‘a e ngaahi ako’ni. ‘Oku tokoni ia ki he feinga ‘a e ‘Ofisi ‘Atita’ ke lelei ange ‘emau fakahoko fatongia.

‘Oku kei hokohoko atu pe ‘a e ‘Ofisi hono kumi ha faingamālie ako ngāue ki ha ngaahi ‘ofisi ‘i muli ‘i he tafa’aki ‘o e ‘atita ki he maa’usia ‘o e ola. ‘Oku lolotonga lele lelei pe mo e ngaahi ako fakalakalaka fakapolofesinale ki he faka’ilonga CPA mo e CA. ‘Oku kei hoko pe ‘a e ‘Ofisi ‘o e ‘Atita Seniale’ ko e Ako’anga Tauhitohi Fakapolofesinale ‘i he malumalu ‘o e ‘Apiako Tauhitohi Fakapolofesinale ‘a ‘Aositelēlia mo Nu’usila.

'Atita'i 'o e Ngaahi Fakamatala Pa'anga 'a e 'Ofisi 'o e 'Atita Seniale 2017-18.

Kuo kakato 'a hono 'atita'i tau'atāina 'o e ngaahi fakamatala pa'anga 'a e 'Ofisi 'o e 'Atita Seniale' ki he ta'u fakapa'anga na'e ngata 'i he 'aho 30 'o Sune, 2018 pea 'oku 'oatu heni ko e konga 4 'o e fakamatala fakata'u' ni. Ko e 'Atita, Grant Thornton New Zealand Audit Partnership, na'a'ne fakamo'oni kakato ki he ngaahi fakamatala pa'anga' tatau pē mo e ta'u 2017. Ko e toe makamaile eni ko e fakakau 'o e fakamatala pa'anga 'osi 'atita'i 'o e 'Ofisi 'o e 'Atita Seniale' ki he 'ene fakamatala fakata'u 'o e ta'u pe ko ia.

'I hono fakakātoa, na'e 'i lalo pe 'a e fakakātoa 'o e fakamole 'i he patiseti 'aki 'a e \$405,590, fakafuofua ko e peseti 'e 21 (21%). Ko e pa'anga ko ia' 'oku mei he ngaahi lakanga 'oku kei 'atā.

Ko e vave 'a e kakato 'o e ngaahi fakamatala pa'anga 'a e 'Ofisi 'Atita, 'atita'i tau'atāina pea fakamo'oni kakato 'a e 'Atita ki he ngaahi fakamatala pa'anga, pea fakahū atu fakataha mo e fakamatala fakata'u 'a e 'Atita Seniale, ko ha faka'ilonga ia 'o e mātu'aki mateuteu 'a e 'Ofisi'ni ke'ne tokanga'i pē hono 'inasi mei he patiseti mavahe mei he Falepa'anga 'o kapau 'e 'i ai ha fokotu'utu'u pehē 'i he kaha'u.

Polokalama Komipiuta Fo'ou ki he Ngāue Faka'atita, TeamMate

Ko e TeamMate ko e polokalama komipiuta ngāue faka'atita ia 'oku ngāue lahi 'aki 'e he ngaahi 'ofisi 'atita lahi. Na'e vakai'i pea fakatau mai 'a e polokalama'ni 'e he 'Ofisi 'o e 'Atita Seniale 'i Me-Sune 2015. 'Oku'mau lolotonga fakahoko hono ngāue'aki 'o e polokalama'ni pea kuo ngāue'aki 'e he ngaahi timi' he 'oku'ne tokoni pē mei he palani, ngāue ki tu'a, fakamā'opo'opo, 'o a'u ki he fai 'o e lipooti. 'Oku'ne tokoni ki he kau 'ofisa 'atita 'i he levolo kotoa pē ki he vave ange mo maau ange 'o e fakahoko 'o e 'atita'. Kuo kau atu 'a e 'Ofisi 'o e 'Atita Seniale mo e ngaahi 'Ofisi 'Atita 'o e ngaahi fonua fakalakalaka 'i hono ngāue'aki 'o e polokalama 'atita'ni ke tokoni'i 'ene ngaahi ngāue.

'Oku lolotonga feinga lahi 'a e TOAG ke ngāue'aki kakato 'a e polokalama'ni pea 'oku tokoni mai mo e kautaha 'oku 'anautolu ia' pehē ki he Kautaha 'a e Ngaahi 'Ofisi 'Atita 'a e Pasifiki, PASAI.

Ko e Ngaahi Pole

Ko e pole lahi taha ke 'ohake 'o e pōto'i ngāue 'o e kaungāue ki he tu'unga lelei mo fakapolofesinale 'oku fakahoko 'aki 'a e 'atita' ke fenāpasi mo e fiema'u ke a'u ki ai 'a e ngāue, pea 'oku'mau 'ilo'i pe ko e fekuki mo e pole'ni 'e taimi lōloa. Ko e hokohoko atu ko ia 'o e ako ki he kaungāue' 'i he ngaahi founa kotoa pē; ako mo e fakahinohino lolotonga 'o e ngāue, kalasi ako makehe fakalele 'e he 'Ofisi, PASAI, IDI, ako ngāue taimi nounou 'i he 'Ofisi 'o e 'Atita Seniale 'a Nu'usila mo 'Aositelēlia, pea mo e polokalama ako fakapolofesinale 'a e 'Ofisi' 'oku fakataumu'a kātoa pe ia ke tali 'aki 'a e pole ko 'eni' 'i he taimi kotoa pe.

Ko homau ivi fakapa'anga 'a ia 'oku 'omai 'i he patiseti fakata'u 'a e Pule'anga' 'oku hoko ma'u pe ia ko e pole ki he 'emau ngāue pea pehē ki he tu'u tau'atāiana 'a e 'Ofisi 'o e 'Atita Seniale'. Na'e fakafiefia ko e fakalahi 'o 'emau patiseti ki he 2014–15 'o lava fakatau mai ai 'a e Team Mate pea hoko mai ai pe ki he totongi fakata'u ki he kautaha' ni 'i he patiseti 'o e ta'u ni, 2017-18. 'Oku mau 'amanaki pē 'e hokohoko atu hono fakafaingamālie'i mai 'o 'emau patiseti fakata'u' ke malava lelei 'a e ngaahi ngāue 'a e 'Ofisi' tānaki fo'ou mai foki ki ai 'a e totongi fakata'u ki he kautaha 'oku 'a'ana 'a e Team Mate ki hono tauhi mo fakalakalaka fakata'u.

'Oku mau fiefia ma'u pe 'i he tu'u mai 'a e ngaahi kautaha tokoni fakalakalaka 'o tokoni 'i he ngaahi tapa 'oku 'ikai malava 'a 'emau patiseti fakata'u 'o fuesia. 'Oku mau fakatauange pē 'e hokohoko atu pē hono tokonia kimautolu 'e he ngaahi kautaha' ni 'i he kaha'u' na.

Ko e pole anga maheni pe foki ia 'a e feinga 'i he taimi kotoa pē ke kakato taimi totonu 'a e ngaahi 'atita' pea ko e kupu 'ikai le'ea 'a e tōmui hono fakahū mai 'o e fakamatala pa'anga ke 'atita'i; fakamatala pa'anga 'a e Pule'anga, ngaahi fakamatala faka-kuata, ngaahi kautaha fakapule'anga, pea pehē ki he ngaahi poloseki fakalakalaka. Ko ia, kuo mau kamata fakapolokalama'i leva 'o fokotu'u 'a e taimi tēpile ke kamata ai 'a e fo'i 'atita takitaha 'o tufaki kiate kinautolu ngaahi kautaha pe potungāue 'oku nau kaunga ki henī' na'a tokoni ki hono matatali 'o e pole'ni.

Ko e Vakai ki he Kaha'u

Ko e feinga ki he fakalakalaka ‘a e ‘Ofisi ‘o e ‘Atita Seniale’ ko e ‘asenita ia ‘oku hokohoko atu pē. Ko e feinga ke langa’i hake ‘a e mafai pōto’i ngāue ‘o e kaungāue’ ‘a e mahu’inga taha mo fai ki ai ‘a e fakamama’u’, he ko ia ia te ne langa’i hake ‘a e tu’unga lelei mo taau ‘o hono fakahoko ‘o e ngaahi ‘atita kotoa pē.

‘Oku’mau lolotonga feinga ki ha faingamālie ako ngāue ma’ae kau ‘ofisa mā’olunga ki he ngaahi ‘Ofisi ‘Atita mā’olunga mo fakalakalaka ange, kae tautaufito ki he ‘atita maa’usia ‘o e ola.

‘Oku’mau lolotonga ngāue’aki ‘a e polokalama komipiuta ko ia ko e TeamMate, ki he kotoa ‘o e ‘atita ‘o e ngaahi ngāue fakapa’anga mo e ‘atita ‘o e faipau ki he lao’ fakataha mo e ngaahi tokoni mei he kautaha ‘oku ‘anautolu ‘a e polokalama pehē mo e kautaha ‘a e ngaahi ‘ofisi ‘atita fakapule’anga ‘o e Pasifiki, *PASAI*. ‘Oku’mau feinga ke’mau ngāue kakato ‘aki ‘a e polokalama’ ni ‘i he kaha’u vave mai.

Ko e polokalama ako ki he tu’unga fakapolofesinal ‘o e kaungāue ‘oku hokohoko atu pe, ‘i he lolotonga’ni ‘oku lolotonga feinga ‘a e toko 4 ki honau CA pe CPA pea ko e toko 7 ‘oku’nau ngāue pē mo ako ki honau ‘uluaki mata’itohi ‘i he va’a USP ‘i Tonga’ni pe Va’a Ako Faka’unesiti ‘a Tonga (*TIHE*). ‘Oku fakalotolahi kiate kinautolu ‘e he ‘Ofisi pea mo e ngaahi tokoni kotoa pe ‘oku’mau malava ma’u.

Ko hono toe fokotu’utu’u fo’ou ‘o e fa’unga ‘o e ‘Ofisi na’e hā atu ‘i he lipooti fakata’u 2015-16 na’e kamata ‘i he 2017-18 ‘aki ha va’a ngāue faka’atita pe ‘e tolu (3): Va’a ‘Atita ‘o e Ngāue Fakapa’anga; Va’a ‘Atita ‘o e Maa’usia ‘o e Ola; Va’a ‘Atita ‘o e Faipau ki he Lao’.

‘Oku’mau ngāue ke väofi mo e Kōmiti Pa’anga ‘a e Falealea’ pehē ki he Kōmiti Vakai Faka’atita ‘a e Kapineti’ tautaufito ki hono siofi ‘o e ngaahi lipooti ‘a e ‘Atita’ mo e hā ‘a e ngaahi tali mo e ngaahi ngāue ki he lipooti ‘a e ngaahi sino na’e ‘atita’i. ‘E mātu’aki tokoni eni ki he anga haohaoa, fatongia taliui, mo e ‘ata-ki-tu’a ‘o e kotoa ‘o ‘etau ngaahi ngāue.

‘Oku hokohoko atu ai pē ‘emau feinga tūkuingata ki he’emau kaveinga ngāue, ‘a ia na’e kamata ‘i Sanuali 2016 ko e “*Anga Haohaoa, Taliui, mo e Ata-ki-tu’u*” pea ‘oku kamata pe foki ‘iate kimautolu mo e kotoa ‘o ‘emau ngāue faka’atita, ‘emau ngaahi lipooti mo e ngaahi fale’i pea hoko atu kiate kinautolu ‘oku mau ‘atita’i, hē ‘e mātu’aki ‘aonga ia ki he ngāue fakalukufua ‘a e Pule’anga ko e konga ‘o e ngaahi me’afua ki hono fakalahi hotau ivi mo ‘etau tupulekina.

1. FAKAHOKO FATONGIA MO E IVI NGĀUE

1.1 Fakahoko fatongia

Ko e fatongia maheni ‘o e TOAG’ ke ‘oatu ‘a e fakamatala tau’atāina kuo fakapapau’i pe a mo e fale’i ta’efilifilimānako ki he Sea ‘o e Fale Alea, ‘i he anga hono ngāue’aki mo hono fakamā’opo’opo ‘e he ngaahi Potungāue ‘a e Pule’anga’ mo e ngaahi ngāue’anga kehekehe ‘a e Pule’anga’ ‘a e pa’anga fakapule’anga. Ko e fatongia’ni ‘oku fakahoko ‘o e ‘atita pea lipooti pē ‘oku fakahoko mo fakamatala’i ‘a e ngaahi ngāue ‘a e pule’anga’ ‘o fakatatau mo e ngaahi lao, ngaahi makatu’unga fakatauhitohi mo faka’atita fakavaha’apule’anga, pea mo e ola na’e a’usia.

1.2 Tefito’i koloa ‘oku ngaohi ‘e he ‘Ofisi

Ko e tefito’i koloa ‘oku ngaohi ‘i he ‘Ofisi’ ‘i he ta’u ‘oku fakakalakalasi ia ki he kalasi ‘e fā (4):

- Poupopu mo e ngaahi ngāue ki Fale Alea
- Sivi faka’atita ‘a e ngaahi ngāue fakapa’anga
- Sivi faka’atita ‘o e maa’usia ‘o e ola
- Sivi faka’atita ‘o e Faipau ki he Lao

(*Fakaikiiki ‘oku hā atu ‘i he 2.1 mo e 3 ‘o e lipooti ko ‘eni*)

1.3 Fa’unga ‘o e ‘Ofisi

‘Oku hā atu ‘i he *Fakatātā 1* ‘a e fa’unga ‘o e ‘Ofisi ‘o e ‘Atita Seniale (TOAG) ‘i he ‘aho 30 ‘o Sune, 2018. Ko e va’a ngāue ‘e fā (4) ‘o e Tafa’aki Pule’i mo e Tafa’aki Ngāue Faka’atita, ‘a ia ‘oku tataki ‘e he kau Talēkita Pule ‘e 4. Ko e Tafa’aki Pule’i ‘oku tokanga ia ki he pule’i ‘o e ‘ofisi’ mo e ngaahi ngāue tokoni ki he ngaahi Va’a kehe. Ko e Tafa’aki Ngāue Faka’atita’ ‘oku vahevahe ia ki he va’a ‘e tolū(3); (i) ‘Atita’i ‘o e fakamatala pa’anga pe a ‘oku nau sivi faka’atita ‘o e fakamatala pa’anga ‘a e ngaahi kautaha ‘a e pule’anga mo e fakamatala pa’anga ‘a e Pule’anga, (ii) ‘atita’i e ola ‘o e fakahoko fatongia mo hono vakai’i ‘e ola ‘o e ngāue, (iii) ‘atita’i ‘o e ngaahi potungāue ‘a e pule’anga mo e ngaahi fakafofonga fakapule’anga kae’uma’ā hono ‘atita ‘a e ngaahi poloseki fakalakalaka.

Ko e ngaahi fakamatala eni ki he ngaahi koloa ngaohi na'e 'ikai ma'u hono tāketi:

1. *Koloa ngaohi 2*, Na'e ngāue 'a e va'a'ni ki he ngāue 'e 2 na'e fiema'u mavahe mai pea na'e fakakakato ia. 'Oku tala 'e he ola totonu, 'a e lahi 'o e fakamatala pa'anga na'e fakahū mai lolotonga 'o e ta'u ke 'atita'i pea na'e lava lelei ia. Neonga na'a'mau palani mo e 'amanaki ki he fakakatoa', kā 'oku fakangatangata ma'u pē ki he ngaahi fakamatala pa'anga 'oku fakahū mai.
2. *Koloa ngaohi 3*, hangē ko e ngaahi ta'u ki mu'a, talu mei hono fokotu'u 'o e va'a'ni ko e taha eni ha pole ki he TOAG 'a e 'ikai ke ma'u ha taukei pe pōto'i fe'unga ke fakahoko 'a e ngāue 'atita ki he maa'usia 'o e taumu'a.


2.3 Fakafehoanaki ‘o e pa’anga hūmai totonu mo e hūatu totonu 2013-14 ki he 2017-18



3. LIPOOTI 'O E NGAALI VA'A

'Oku 'oatu 'a e fakamatala fakanounou ki he kātoa 'o e ola fakalukufua 'o e ngaahi ngāue na'e fakahoko lolotonga 'a e ta'u fakapa'anga 2017-18. Ko hono fakaikiiki 'oku hā atu 'i ha lipooti makehe 'a e ola fakakātoa 'o e ngāue faka'atita ki he ngaahi ngāue fakapa'anga mo e faipau ki he lao 'i he lolotonga 'o e ta'u fakapa'anga ko'eni.

3.1 Va'a Ngāue Tokoni Faka'ofisi

3.1.1 Puipuitu'a

Ko e va'a ngāue tokoni faka'ofisi' 'oku'ne fakahoko 'e ia 'a e ngaahi ngāue poupou hangē ko e talitali kakai, tauhi ngaahi faili, Tekinolosia Faka-komipiuta (IT), ngaahi ngāue ki he me'a fakakaungāue, fakamo'oni'i 'o e ngaahi monū'ia 'o kinautolu kuo nau penisoni, ngaahi 'esitimeti, tufaki 'o e ngaahi tohi, laipeli, naunau faka'ofisi, nofo'anga, tu'utu'uni kaungāue etc. 'Oku'nau toe fatongia'aki 'a e *Koloa Ngaohi 1: Lipooti ki Hale Alea mo e ngaahi tokoni kehe*.

Ko e kaungāue 'e toko 10 fakakātoa 'i he va'a'ni 'o taki ia 'e he 'Atita Pule, Lotomo'ua Tu'ungafasi. Lolotonga 'a e ta'u na'e kei mama'o atu ai 'a Lotomo'ua Tu'ungafasi mo ha 'Ofisa 'e tokotaha 'i ha faingamālie ako ki he fonua muli pea ko e 'Atita Seniale pē 'oku'ne tokanga'i ofi 'aupito 'a e va'a ko'eni.

3.1.2 Fakamā'opo'opo 'o e koloa ngaohi

Na'e palani mo patiseti 'a e va'a'ni ki he koloa ngaohi 'e 13 'i he houa ngāue 'e 9,199. 'I he faka'osinga 'o e ta'u, na'e lava 'e he va'a'ni ke'nau fakahoko kakato 'a e koloa ngaohi na'e palani'i 'i ha houa ngāue fakakātoa 'e 9,270 'o laka ia 'i he houa fakakātoa na'e patiseti. Ko e monū he na'e toe tānaki mai mo e houa (71) 'akinautolu 'o e kaungāue 'i he va'a'ni na'e tolo i atu 'enau poaki mālōlō ka na'e 'osi papau ke fakahoko.

AUDITOR-GENERAL'S REPORT

The Auditor-General presents this report together with the financial statements of the Tonga Office of the Auditor General (TOAG) for the year ended 30th June, 2018 and the auditors' report thereon.

State of Affairs

The Auditor General is the principal auditor of government, responsible for performing financial, compliance and performance audits of public funds. This includes the audit and reporting of results to the Legislature through the Speaker on the financial conditions of Ministries, Departments, Agencies, Public Enterprises and Development Projects: and for the review and approval of audited accounts of public enterprises that are audited by private firms.

On the 6th January, 2014 all staff are now under the management of the Auditor General since the amendment of the Public Audit Act 2012.

Corporate Governance

There is no separate bank account for TOAG, Ministry of Finance and National Planning keeps all the bank accounts for all Ministries, Department and Agencies (MDAs). Therefore the government accounting system is centralized in the Ministry of Finance and National Planning. The TOAG during this time used the current system for preparing the financial statements.

All MDAs are required to maintain copies of accounting records when payments are made. A monthly reconciliation of TOAG manual vote book against the Ministry of Finance and National Planning is required to be carried out. Financial rules and regulations are set by the Ministry of Finance and National Planning for all financial matters of the Government to be followed.

1. NGAALI TU’UTU’UNI NGĀUE FAKATAUHITOHI (ACCOUNTING POLICIES)

a) Makatu’unga ‘o e teuteu (Basis of Preparation)

Na’e teuteu’i ‘a e ngaahi fakamatala fakapa’anga’ ‘o fakatatau ki he Founga Fakatauhitohi Fakamāmani Lahi ma’ae pule’anga ‘i he Makatu’unga Fakapa’anga ‘o e Tauhitohi. This comprises the TOAG which is controlled by the national government of Tonga. The principal activity of the TOAG is to provide audit services to assist the executive supervision of the use of public funds and resources*).

2. PATISETI ‘O E NGAABI PA’ANGA KUO FAKAHŪ ATU KI HE NGAABI NGĀUE ‘A E PULE’ANGA (BUDGET APPROPRIATIONS)
